Predictive Analytics Workshop for Executives

We're putting together an indepth executive level workshop that looks at predictive modeling in action. Built on the foundation of historical data, we'll explore how to work with projections and putting predictive analytics to use alongside program evaluation and research.

Statistical analysis is not the same as predictive analytics. In this workshop, learn about the science behind predictive analytics and using it in complex systems. We'll dig into discoveries and surprising findings to better understand what makes the most difference in outcomes for a child. Models in this workshop will include (1) recurrence (2) failed reunification and (3) delayed permanency.

Highlights & Hot Topics

- MindShare Predictive Modeling efforts for Recurrence were presented at the International Society for the Prevention of Child Abuse and Neglect in Japan the week of September 14, 2014.
- * MindShare is working with Walter R. McDonald and Associates to test its Predictive Models using NCANDS nationwide datasets.
- * MindShare forges ahead with data sharing of school records between Lead Agency and School Board for High Impact Visibility to critical child factors to improve safety and well-being between agency and school staff. Sharing currently in place with Polk, Pinellas, Hillsborough and Miami. More to come...
- MindShare forms strategic relationship with The Washington Group, working together to expand legislative request for SACWIS systems specifically to expand Requirement 87. Additional interfaces to explicitly call out 3rd party reporting systems. The Automated System must provide for the effective, economical, and efficient transfer of information between SACWIS and other (approved) 3rd party data reporting systems.
